The last year ended on a somber note, with COVID19 creating havoc all around, spreading a carpet of gloom in the villages. The pandemic brought with itself a triple setback for the rural poor –the fear of catching the virus, and a total loss of incomes further compounded by the return of the migrants. The immediate days got hectic as all of us at SEBA JAGAT plunged into the thick of action, making available relief to the stranded people and also mobilizing communities on disease prevention. Long years of assiduously building social capital, stood us in good stead, as we reached out to the neediest people with critical help.

Our community outreach last year touched 58300 poor households spread out in 972 villages. The SHGs of women from these households led the change process. SEBA JAGAT worked on a Comprehensive Livelihoods approach, which sought to create sustainable livelihoods; put incomes in the hands of the women, at the same time ensuring that no poor person is left out. We also initiated big-time partnerships with the government to unlock large finances. In fact, opening up many avenues of such partnerships marked the year for us, which brought into focus SEBA JAGAT 's convening abilities through these multi-stakeholder partnerships,

Even as we continued to innovate and broaden the scope of our community engagement, internally we continued our efforts to make SEBA JAGAT a more democratic and gender-egalitarian organization. We spent the year incessantly reviewing and evaluating SEBA JAGAT's space in the larger world, as we voyaged on towards creating a just and equitable society. In the following pages, we open a few facets of that journey as an invitation to all our friends to come and join us – to make the journey more soulful, more meaningful

Sustainable Livelihood...

ICRG programme in support of UNDP aims to improve climate resilience of vulnerable people with improved resilience and productivity of the infrastructure built under MGNREGS . The project is implemented by Seba Jagat in 36 Panchayas of 6 Blocks in Kalahandi district. The present report is the 2nd deliverable for the period of December 2020 to July 2021. It gives a detailed analysis of what is done in the period as per the plan, major highlights as well what is the next planning along with small case studies. The programme during the period facilitated with GP and Block to take up 70 CRWs in a larger scale in an integrated way (one core structure and few ancillary structure as per the need of the area) and link the CRWs to livelihoods by leveraging resources from line departments and included annual plans for MGNREGS in the context of climate change, watershed based/scientific planning in ICRG blocks. Innovative models like roof water harvesting structure is also included in the programme. During the period we have tried to facilitate institutional linkage with OLM, ITDA, Agriculture , horticulture dept etc to demonstrate convergence models



Key Achievement

- District and Block administration appreciated the ICRG programme and its model and suggest to line dept. for effective implementation of ICRG programme and to replicate it.
- Identification of the need based NRM work
- Resources/ Social mapping of the village/GP.
- Selection of the work relevant to climate sensitive.
- Preparation of potential list of works recommended under MGNREGA.
- Identification of active job card holder of the village.
- Identification of climate sensitive works of line Dept. Of the concern village like Forest, Agriculture, Horticulture, water shade.
- Issue identification with prioritize and short out the solution
- Focus need based NRM work must be included 60% of total LB of concern proposal.
- Engaged 100 days to active job card holder in a calendar year to MGNREGA.
- Focus on need based community and individual work.
- PRA exercise with GRS, Mates, PRIs and concern community volunteers through KUNJI game.
- Participating in GP level Annual action Plan and assist ,orientation ,motivation, on ICRG protocol regarding situation analysis like Rain fall ,Drought, Flood, in last 3 years with community participation and need based structure identify.
- Focus on Seba Jagat innovative structures Roof/Rain water harvesting structured to create a model and also tube well shock pit in each tube well at ICRG model GP plan
- Approval of 70 CRW along with integrated work
- Community involvement in planning process
- Involvement of PRI with line dept.

Small Efforts Lead to Milestones

Rendabahali Village is situated around 60 K.M. distance from district head quarter Bhawanipatna and 25 K.M. distance from Narla Block. Rendabahali village is Under Takarla GP and known as backward Tribal Village of Narla block. Out of 51 Household 30 Household is belong to ST Community and 10 no's household are Scheduled Caste communities. The Main income source of the people is agriculture and wage works. Beside this they are depending on village forest for collection of Non Timber Forest Produces for their livelihood. It is difficult to maintain their family ,day to day expenses to Purchase vegetable, nutrition food to consume on regular basic..

Due to the COVID-19 pandemic situation in all over the country and strict guideline of the Central/State Govt. , Odisha Govt. also stop the MGNREGS work.



So the laborers faced more financial problem to maintain their livelihood. Meanwhile Seba Jagat ICRG volunteers Sri Khetra mohan Padhan identified Mr Antaryami Patra a small and marginal farmer and provided some inputs like vegetable seeds i.e, brinjal 10grams,tamato 10g Chhili, organic manures, nim Oil, sprinkler, drumstick plant, papaya for kitchen garden under COVID-19 ICRG programme. Mr Antaryami Patra dedicatedly cultivated vegetables and also selected through Mahalaxmi SHG by OLM and got a MUB under MGNREGA and linked @ Rs.13500. Mr Patra as a active job card holder of Rendabahali village so he self engage in his MUB and got Rs 6000. Mr Patra is so happy to create a kitchen in his own land and consumed green vegetables in regular basic and selling the rest vegetables in market and maintained their family with happiness.





NRM Base Livelihood Prog.

MGNREGS world's one of the largest development programme in human history is primarily intended to enhance the livelihood securities of the people in rural areas by supplementing wage employment opportunities to the unskilled labor force. The main objective of MGNREGS is to provide livelihood security to the rural poor through creation of quality and durable community and individual assets that provide sustainable income. The programme is in force with the intention that it would act as a strong safety net for the poor in the wake of lack of alternative employment opportunities. In an attempt to ensure the rural economy to grow, the scheme is expected to regenerate the rural natural resource base for sustainable livelihood by carrying out soil and water conservation activities

With the objective of arresting distress migration a partnership between Kalahandi & Nuapada District administration and Seba Jagat.

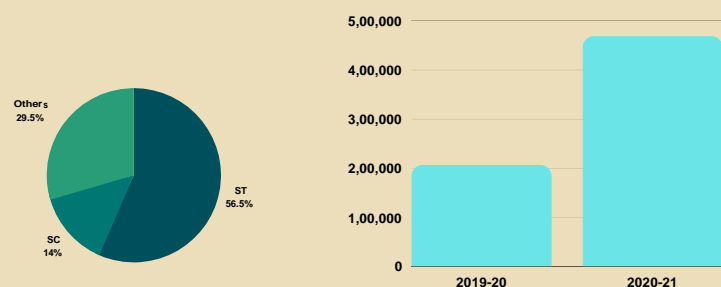
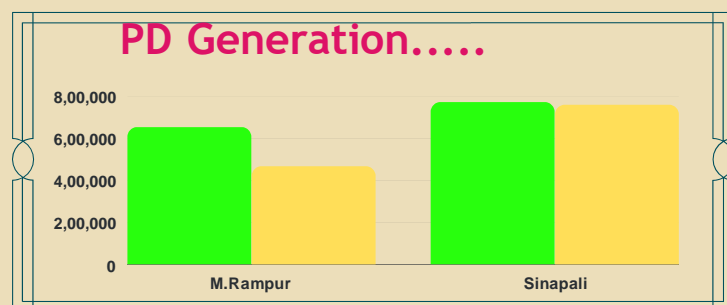

Disaster Management

Communities being the resource pool available at local level are in a better position to plan and execute immediate rescue, relief and rehabilitation actions, provided they are properly capacitated and involved in designing the Village Disaster Management Plan (VDMP) process. Realizing the importance of community's role in disaster management,

During the year, SEBA JAGAT facilitated development of 59 VDMPs spreading over 31 Gram Panchayats of 5 Block ,Kalahandi district .

Analysis of the disaster / vulnerability risks, risk reduction planning for mitigation and preparedness, early warning systems, post disaster relief, participatory monitoring and evaluation were done through organizing community awareness meetings and formed Village Action Team .

Besides, thorough analysis of the environmental situation, identification of the village resources (human, land, water, forest, animal etc.), diagnosis of problems in their respective areas, and finding out solutions on a prioritized basis were made.

The Village Disaster Management Plans (VDMPs) were placed before the Palli Sabha for review and recommendation then approval at the respective Gram Sabha level.

Covid-19 Response Prog.



Regulatory relief Seba Jagat has provided significant relief to industry in relation to the COVID-19 pandemic. The pandemic continues to disrupt business and flying operations and significantly reduce the overall level of aviation activity. We are actively managing our response to the COVID-19 situation to ensure the ongoing safety of aviation, while taking a flexible regulatory approach to help alleviate the pressure. We have also adjusted our approach to surveillance to account for reduced levels of activity and new and emerging sector risks.

Project Area Outreach - M. Rampur, Golamunda, Lanjigarh and Narla block we have identified 213 villages of 4 Blocks in Kalahandi district i.e 145 villages from 8 GPs of M. Rampur block, 10 Villages from 2 GPs of Narla and 22 villages from 7 GPs of Golamunda block and 36 villages from 10 GPs of Lanjigarh Block.

Impacts of the intervention:

- The 3 Self help Group are raising the community Nursery with the support of the Seba Jagat ICRG Project and they are demand to block Administration for convergence with OLM and ATMA project
- 400 families of 25 villages of 5 Grampanchayat of Lanjigarh block of Kalahandi district have received Rs. 5000/- each and restarted their livelihood activities to maintain their family living in this critical situation of covid19
- 1 hand wash station installed and demonstrated handwash practices using various IEC materials in Bengaon Grampanchayat headquarter to inculcate practice of handwash frequently among the people
- 12 different wall painting using pictorial information in local language made to make community aware on covid19 preventive measures.
- Awareness program was organised by the project team and village volunteers using wall painting to make community aware on hand hygiene, respiratory hygiene and physical distancing practices to prevent covid19
- 7500 Mask distribution





FoGGO Net work.

With an aim to harness natural resources to strengthen the ecological balance, CFR managment of community protected forest areas in Kalahandi, Nuapada, Khurdha, Gajapati, Sundargarh, Baragada, Kandhamal & Rayagada with the active cooperation of the forest and revenue department and Project partner . The local CBOs, forest committees, SHGs and local leaders groups actively supported this new initiative. In addition, with the moto of “follow natural process and nature takes care of his own”, seed dibbling process has been initiated targeting an area of 57 hectors of forest land in the region with the cooperation of youth/FRC groups.

Promotion and use of alternative clean energy for better life and Livelihood

The NGO-in –Residency programme has been planned in a way to have sustainable energy solution to enhance Livelihood and also improving quality of life with alternative energy based solution with the support of Selco Foundation. This would encourage innovative models by leveraging and adding to the existing /latent skills. Seba jagat strongly believing on the integrating of renewable energy in its all type of intervention as much as possible in its part. Now it has been internalized that renewable energy is the only alternative of the electricity crisis in the community level and which can be used by any common people.

KEY ACHIEVEMENT

Identified & installed 5 nos of unit for different - Stake holders (3 individual & 2 community) for improving quality of life and to enhance work efficiency for better income of 117 family with energy based solution through development livelihood options. Installed the connection of solar system to the individual entrepreneur (Sewing Machine Unit, LSK Unit, , Blacksmith Unit and Turmeric & Flour processing unit for community based intervention. along with domestic Home light connection has been made in 2 villages (Salepali and Nagjhari) of M.Rampur block..The direct beneficiaries of the project are rural community from 5 G.Ps of M.Rampur & Karlamunda block

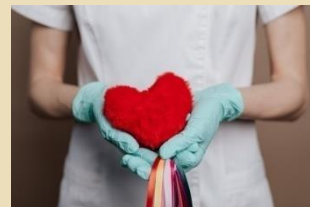
Hosting an AIF Fellow

Health & Wellness Programme

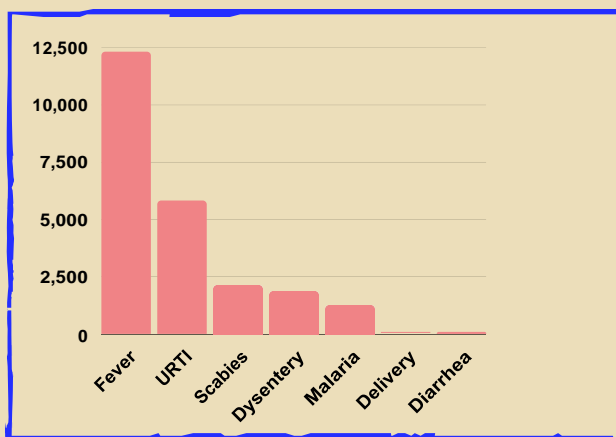
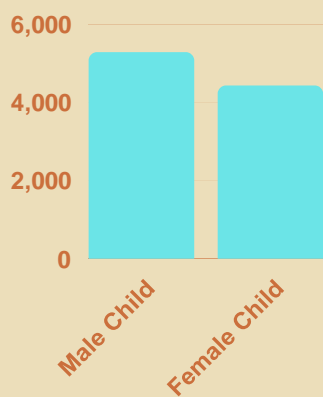
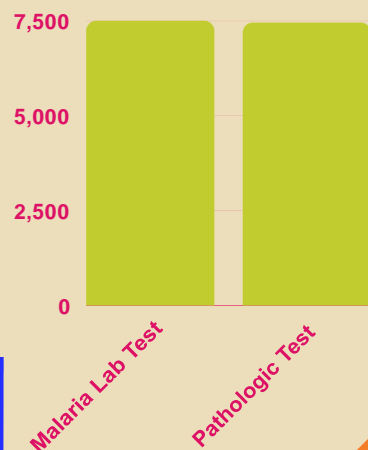
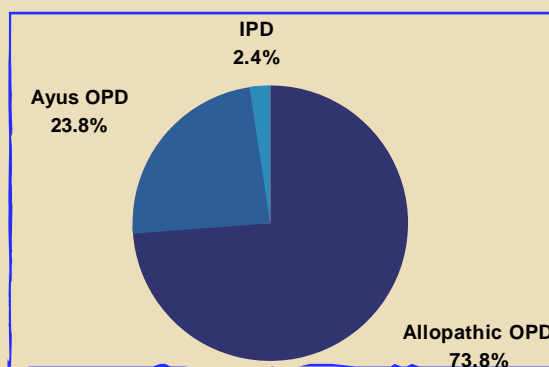
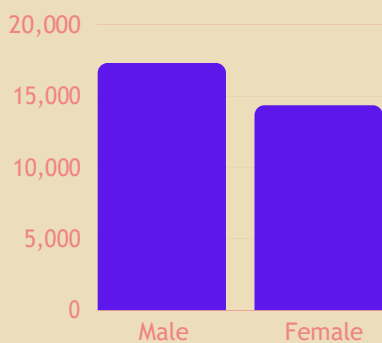


Seba Jagat has taken the management responsibility to run and manage a Health & Wellness Centre, PHCs (new) under Private Public partnership Programme with the support of National Health Mission, Odisha since 12th June-2008 Barabandha PHC(N), from 9th June 2020 Bengaon PHC(N) in Kalahandi district and 5th November 2020 of Lankagarh PHC(N) in Kandhamal district. These PHCs are serving to people living in one of the most remote areas of Kalahandi and Kandhamal district. One M.B.B.S Doctor, Ayush Doctors, Pharmacists, and ANM, Laboratory Technician and Ward Attendants are appointed by the organization to run the PHCs. The people from around 38 villages in Barabandha and also nearest Gram Panchayat, 33 Villages in Bengaon GP and 118 villages others nearest GP of Kalahandi District and 36 villages of Lankagarh GP and also nearest GP of Kandhamal District get health services. People are depending on this Centre for their primary and emergency health services. The Hospital is functioning on 24 x 7 basis and on an average 45 patients in each PHC are getting treatment regularly and many critical patients have been able to survive.

An Integrated Community Mobilization Initiative for Improved Access and Demand for Health, Nutrition & Sanitation Services in Kalahandi

Objective of the prog.

Broad Objective

To enhance the uptake of health, nutrition and sanitation services among vulnerable communities for improved child survival in 2 Blocks of Kalahandi in support to the implementation of Sampurna (State Strategy for Accelerated Reduction of IMR and MMR) and rural sanitation programme.

Key Achievement

Key Outcome

Children (0-5 years) , pregnant/lactating women and households in 45 GPs of 2 blocks in Kalahandi have increased access to preventive and curative health services, and caregivers demonstrate positive health and sanitation behaviors to improved child survival (IMR , MMR and Open Defection reduction

Strategies

- Capacity building of formal and informal service providers of line departments including sanitation motivators on technical and communication skills
- Strengthening community mobilization and Community Approaches for Sanitation activities through capacity building of community based organizations/platforms and other stakeholders for positive behavior change.
- Quality improvement of outreach services including improved counseling/IPC during home visits and other CLTS outreach mechanisms through Nighrani Committees
- Partnership with civil society and engaging their strength in BCC

- Result 1: Frontline workers (FLWs) of DHFW , DWCD and PRD working in 45 GPs of 2 Blocks of Kalahandi have improved capacity to deliver quality government services related to infant and young child health ,nutrition and sanitation
- Result 2: Community influencers have enhanced knowledge and skill, promote positive health, nutrition ,sanitation and hygiene behaviors affecting maternal and child health among communities
- Result 3: Families in communities have access to information and counseling to improve the survival and growth of their children and health of mothers
